

## **OVCMT REFUND POLICY**

The tuition and fee refund policy is subject to the minimum requirements set out under the Private Training Act. In the event that the terms of this policy conflict with or are silent on a matter addressed under this Act, those under the Act will prevail. The policy below shows the circumstances in which tuition must be refunded.
